

## 2017 STREET CANOPY CAMPAIGN ORDER FORM

### ANCHORAGE FORESTRY BOARD

**Deadline: September 15, 2017**

The purpose of the Anchorage Street Canopy Campaign is to enhance the shade canopy over our City's streets. The City will pay for half the cost and professional planting of each CANOPY tree ordered. The SPECIAL OFFER trees are not "canopy" trees; they are offered to residents at full wholesale price that includes trees and planting.

**CANOPY TREES** will grow to be large shade trees and must be located

- in level, cleared areas free of brush,
- at least 20 feet from any existing trees, and at least 5 feet from any stumps,
- in well-drained areas not subject to flooding,
- 15-20 feet from the edge of the road, and
- away from utility poles and overhead lines.

**SPECIAL OFFER TREES** may be located anywhere in your front yard except within 15' of the road.

**All planting locations must be approved by the City Forester.** You will be provided flags to identify planting locations. The Forestry Board will contact BUD (Before-You-Dig) to locate and mark buried utilities and will spray-paint approved planting locations to identify them for the installer.

The trees are approximately 2" in diameter. Please check print or internet sources for specific tree characteristics such as height, growth rate, spread, etc. *The Manual of Woody Landscape Plants* is available at City Hall for your use.

#### CANOPY CAMPAIGN AGREEMENT

- I agree that it is my responsibility to locate any invisible fencing or irrigation systems. I am responsible for any repair or expense involving invisible fencing or irrigation.
- I agree to locate my trees per the requirements outlined above.
- I understand there is no warranty on the trees.
- I understand that if the provided marker flags are not in the ground and at the approved location(s) when the installer arrives, I will not receive the ordered trees. It is my responsibility to ensure that service personnel do not remove the flags.
