Large Tree 60-80' tall, Spread 40-50'  
Full Sun



'Green Vase' Japanese Zelkova  
Large Tree 60-70' tall, Spread 40-50'  
Full Sun



'Autumn Gold' Ginkgo  
Medium Tree 50' tall, Spread 30'  
Full Sun



'Red Pointe' Red Maple  
Large Tree 40-50' tall, Spread 25-30'  
Full Sun



'Princeton' American Elm  
Large Tree 50-70' tall, Spread 30-50'  
Full/Partial Sun



'Black Pearl' Eastern Redbud  
**\* Specialty Tree**  
Small Tree 15-18' tall, Spread 15-18'  
Full Sun to Shade  
Purple leaf color best in full sun  
Tolerates Clay Soil
